### 4WD and Off Road Vehicles

The Control of Vehicles (Off-Road Areas) Act 1978 regulates the activities of off-road vehicles.

An off road vehicle is defined as one not registered for on-road use.

Under the Act, "off-road vehicle means a vehicle which is not licensed, deemed to be licensed, or the subject of a permit granted, under the Road Traffic Act 1974;"





#### Requirements for Off-Road Vehicles

All off-road vehicles used in areas covered by the Act, other than on private land with consent of the owner, must be registered under The Control of Vehicles (Off-Road Areas) Act 1978. Road registered vehicles (Licensed) do not require separate off-road vehicle registration.

The following summarises the difference between the two types of vehicles:

#### Registered for off-road use

In order to access the designated off road vehicle areas, motorcycles, guads and other off road vehicles are required to have Off Road Vehicle registration.

Registered off road vehicles are not permitted on public roads.

#### Registration plates must be affixed to the off road vehicle and be plainly visible.

Offroad vehicles can be registered at any licensing centre. All offroad vehicle registrations expire on September 30 each year and must be renewed or the registration plates be surrendered. Registration does not include Third Party Insurance.

#### Registered for limited on road use

An off road vehicle requires to be registered under the Road Traffic Act 1974 if there is a legitimate need to access one or more public roads (for the purpose of crossing).

Penalties (Control of Vehicles (Off-Road Areas) Act 1978)

Off Road vehicles can only be used on permitted areas or on private land with the consent of the landowner.

Various fines apply for vehicles being used in non-permitted areas, such as;

- Section 6 (1) Drive / Ride an off road vehicle in a non-permitted area.
  Penalty \$50, maximum \$500
- Section 7 Any motor vehicle (other than road registered) must be off road registered.
  Penalty \$50, maximum \$200
- Section 9C Failure to wear protective helmets.
  Penalty \$50, maximum \$800
- Vehicles may also be impounded.
