The content and format of fire-break notices varies between Local Governments. Some are limited to section 33 requirements only; however, many contain additional information related to other provisions of the BF Act and the Bush Fires Regulations 1954, and general bushfire hazard and preparedness information.

This session aims to support Local Governments to ensure that the regulatory requirements within the fire-break notice are clear and thereby improve compliance by landowners and occupiers.

The training session will also serve as an opportunity to educate Rangers on essential topics such as

- firebreak notice variations, contractors, correlations to bush fire management plans and state planning policies
- asset protection zones, fuel hazards
- appointing officers, giving notice, gazetting information
- Total Fire Bans (TFB) and Vehicle Harvest Movement Bans (VHMB)
 - o recent regulations changes, public authorities, businesses exemptions and requirements
- Cooking and campfires, burning garden refuge, burning on Sundays
- updates on emergency websites and warnings, and changes to the fire danger rating system.
- latest updates to the fire danger rating system (FDR), Fire Behaviour Index and Emergency WA website
